RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING CHANGES IN THE ESTIMATED COST OF ACQUISITIONS AND INCREASING THE AMOUNT OF THE CITY'S CASH CONTRIBUTION FOR THE SAN DIEGO PARK DISTRICT NO. 12F - TECOLOTE CANYON.

WHEREAS, in proceedings under the San Diego Park District Procedural Ordinance of 1969 the Council adopted resolution of intention, Resolution No. 210795, ordering the City Manager to prepare the report required by said Act, and pursuant thereto the City Manager has prepared said Report, consisting of a description of the property to be acquired for park and recreation purposes, an estimate of the cost and expense thereof, a diagram showing the assessment district, and a proposed assessment of the cost and expense of the proposed improvements, said Report being on file with the City Clerk; and

WHEREAS, the Council adopted Resolution No. 210796 approving said Report, as filed, and appointing the time and place of hearing thereon; and

WHEREAS, on July 18, 1974, the Council conducted a public hearing on said Report and heard all persons desiring to be heard thereon and in connection therewith, and following said public hearing the Council adopted Resolution No. 211118 overruling protests, ordering the acquisition referred to therein, and providing for the City's contribution, in cash and in City-owned land or lands being acquired by the City; and

WHEREAS, on October 24, 1974, the Council adopted Resolution No. 211828 ordering changes in the assessment and in the individual assessments, and increasing the City's cash contribution; and

WHEREAS, on June 5, 1975, the Council adopted Resolution No. 213473 ordering certain changes in the assessment and in an individual assessment, eliminating certain property to be acquired, and correcting the map of the property to be acquired; and

WHEREAS, the value of the property yet to be acquired has increased since it was first estimated by approximately \$750,000, and it is therefore necessary to correct and amend the estimated costs and expenses of the acquisition to reflect such increased value; and

WHEREAS, said increased costs reflect inflationary trends and other factors that do not relate to a special benefit to the assessment district and that should be borne by the people generally; and therefore the City's cash contribution should be increased accordingly to cover said increased costs, said increased costs to be financed through the use of Environmental Growth Funds; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Council hereby orders that the estimated costs and expenses of the proposed acquisitions in these proceedings shall be and are hereby increased to \$6,188,393.68.

2. The Council further orders that the City cash contribution to the project be and the same is hereby increased to \$3,088,121.96.

BE IT FURTHER RESOLVED, that the Auditor & Comptroller be and he is hereby authorized to expend the sum of \$650,000 from Capital Outlay Reserve - Flood Control Right-of-Way (CIP 90-245.2) to be used solely and exclusively as an advance for interim funding for the acquisitions required by the Tecolote Canyon Park District No. 12F, said monies to be reimbursed to the Capital Outlay Fund upon receipt of sufficient Environmental Growth Funds in fiscal year 77.
