WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
John E. Trainor	Transportation	\$405	Mr. Trainor is a Laborer in the Streets Division. He suggested that cap screws be used to mount traffic control signs rather than aluminum brackets. This suggestion will save an estimated \$4,065 in materials costs.
Kenneth R. Wise	Transportation	\$385	Mr. Wise is an Electronics Technician in the Communications Division. He suggested that encoder and decoder cards for microwave multiplex equipment be purchased locally rather than be purchased from the manufacturer. This saves the City \$3,842.
Jack T. Argent	Park & Recreation	\$110	Mr. Argent is a Recreation Supervisor in the Recreation Division. A year ago he devised a method to reinforce basketball back boards to prevent breaking. He originally received a \$50 award. After a twelve month review, it was determined that his suggestion saved a total of \$1,600.
