WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Robert L. Greeson Raymond Molina	Water Utilities	\$20	Mr. Greeson is a Utility Supervisor and Mr. Molina is a Utility Worker II. They suggested safety improvements in the trucks used for cleaning sewer mains. Although no savings can be computed, a \$20 award is merited.
Mathias J. Neuwirth	Transportation	\$10	Mr. Neuwirth is a Senior Utility Supervisor in the Streets Division. He suggested that a safety railing be installed by the swinging doors at the Rose Canyon locker room. Although no savings can be computed, a \$10 award is merited.
Otto D. Wilkinson	General Services	\$10	Mr. Wilkinson is a Building Service Technician II in the Buildings Division. He suggested that safety clamps be installed in the light diffusers at the main Library. This will save \$100 per year in replacement costs.
Robert D. Hoover	General Services	\$20	Mr. Hoover is a Sanitation Crewman in the Equipment Division. He suggested that the oil filler spout on Heil packers be extended upward to prevent spillage when turning. This saved about \$200 per year in fuel costs.
Jose Hernandez	Water Utilities	\$15	Mr. Hernandez is a Treatment Plan Supervisor. He suggested a method of preventing vandalism in sewer manholes in isolated areas. Although his suggestion is no longer in use, a \$15 award is merited for that period it was in use.
