

RESOLUTION NO. 216369 JUL 7 1976

WHEREAS, on November 1, 1973, The City of San Diego entered into a lease with Computer Machinery Corporation (CMC) for the lease of data processing equipment for the period of five (5) years with an option to renew for two (2) additional one-year periods; and

WHEREAS, on March 30, 1976, CMC was acquired by Pertec Corporation (PERTEC) pursuant to a plan of reorganization and agreement approved by the shareholders of CMC on February 24, 1976; and

WHEREAS, it now becomes necessary for the City to consent to the assignment by CMC of all CMC's right, title and interest in the agreement with the City to PERTEC and the assumption by PERTEC of all CMC's liabilities and obligations to the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby empowered to consent to, for and on behalf of said City, the assignment of rights, title, interest, liabilities and obligations of Computer Machinery Corporation to Pertec Corporation in a lease with The City of San Diego which was approved by Resolution No. 209067 on October 25, 1973, under the terms and conditions set forth in the form of assignment on file in the office of the City Clerk as Document No. 755848.
