RESOLUTION NO. 216409 JUL 14 1976

WHEREAS, heretofore by map recorded July 2, 1952 in the Office of the San Diego County Recorder, the City acquired an easement for underground utilities across a portion of Lots 1 through 10, inclusive, Block 54 of Linda Vista Unit No. 1; and

WHEREAS, said underground utility easement has never been used for the purpose for which it was acquired since the date of acquisition to the present time and more than one year has elapsed; and


WHEREAS, the City has no present or prospective use for said easement and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That The City of San Diego by this resolution does hereby abandon whatever right, title or interest it may have in that private underground utility easement more particularly described in the legal description attached hereto as Exhibit A and incorporated herein.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the San Diego County Recorder.

LEGAL DESCRIPTION OF UNDERGROUND
UTILITIES EASEMENT TO BE
ABANDONED BY CITY OF SAN DIEGO

All that portion of Lots 1 through 10, inclusive, in Block 54 of Linda Vista Unit No. 1, according to Map thereof No. 2883 filed in the Office of the San Diego County Recorder July 2, 1952, more particularly described as follows:

That certain "8.00 foot wide easement for underground utilities, 4.00 feet on each side of lot line in Block 54, Ulric Street to Comstock Street", as set aside by the recording of said Map 2883."
