

RESOLUTION NO. 216410 JUL 14 1976

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Mira Mesa Boulevard and Frontage Road, affecting Lot 2 of Mira Mesa Village Unit No. 2; and

WHEREAS, the Engineering and Development Department has requested that the City re-vest these abutter's rights of access in the property to TITLE INSURANCE AND TRUST COMPANY, a California corporation, the owner of said property, to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be re-vested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the re-vestment of said abutter's rights of access; and

WHEREAS, a fee of \$65.00 has been received to cover the processing of this request; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and


WHEREAS, the City Manager recommends that said access rights be re-vested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 755964, to TITLE INSURANCE AND TRUST COMPANY, a California corporation, owner of Lot 2 of Mira Mesa Village Unit No. 2, effecting the revestment of those abutter's rights of access in and to Mira Mesa Boulevard and Frontage Road, more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
