

RESOLUTION No. 216411Adopted on JUL 14 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date of June 8, 1976, conveying to said City an easement for public street or highway purposes over and upon portions of Lots 7 and 8 in Block 32 of South Park Addition, a portion of 30th Street now vacated, a portion of Lot 25 of Block 91 of E.W. Morse's Addition, portions of Lots 22, 23 and 24 of Block 92 of E.W. Morse's Addition, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named FERN STREET; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named 30TH STREET.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
