

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the UNITED STATES OF AMERICA, DEPARTMENT OF THE NAVY, WESTERN DIVISION, NAVAL FACILITIES ENGINEERING COMMAND, for the relocation of a damaged portion of the Point Loma Sewer Treatment Plant Sludge Line, under the terms and conditions as set forth in the form of agreement on file in the office of the City Clerk as Document No. 755974.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to accept the sum of \$9,922.94 pursuant to said agreement as reimbursement for expenses incurred in relocating the sludge line.
