

RESOLUTION NO. 216426 JUL 14 1976

WHEREAS, the Chicano Community Health Center is a community based health agency in the Logan Heights area dedicated to serving the health needs of the working poor at little or no cost; and

WHEREAS, with the expansion of the Center's patient load and added clinic services, additional funds are desperately required for expansion of facilities; and

WHEREAS, the Mexican American Foundation is producing an "Evening with the Stars" as a fund-raising event for the Chicano Community Health Center; and

WHEREAS, such funds as may be raised by this event will be allocated to such expansion of facilities; and

WHEREAS, The City of San Diego considers such event to be worthy of sponsorship in that the objectives contribute to the enhancement of the well-being of the community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That The City of San Diego does hereby agree to cosponsor with the Mexican American Foundation the fund-raising event "Evening with the Stars" to be conducted on July 16 and July 17, 1976, at the Civic Theatre, Golden Hall, and Plaza Hall.


BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$1,700 from the Transient Occupancy Tax Unappropriated Reserve Fund (224)

to the Convention and Performing Arts Center Fund (254) to be expended solely and exclusively for payment of rental fees of the Civic Theatre, Golden Hall, and Plaza Hall for the "Evening with the Stars" event cosponsored by The City of San Diego and the Mexican American Foundation on July 16 and July 17, 1976.

BE IT FURTHER RESOLVED, that the City Manager be authorized to enter into a suitable agreement consistent with Council Policy No. 100-3. (Form of Agreement - Document No. 755928)
