RESOLUTION NO. 216430 JUL 14 1976

RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO DECLARING THE RESULTS OF THE CANVASS  
OF THE SPECIAL MUNICIPAL BOND ELECTION AND THE  
SPECIAL MUNICIPAL ELECTION HELD ON JUNE 8, 1976  
ON ONE BOND MEASURE AND THREE PROPOSITIONS TO  
AMEND THE CITY CHARTER.

WHEREAS, this Council by Ordinances Nos. 11820 and 11821  
(New Series) adopted March 25, 1976, called a special municipal  
bond election and a special municipal election to be held in the  
City on June 8, 1976; and

WHEREAS, these special municipal elections were duly  
consolidated with the statewide primary election held upon the  
same date; and

WHEREAS, the special municipal bond election and the special  
municipal election were held on June 8, 1976, for the purpose of  
proposing and submitting to the qualified electors of the City  
four propositions as follows:

PROPOSITION F:

PROPOSITION F. CITY OF SAN DIEGO BOND PROPOSAL  
FOR THE PURCHASE OF CERTAIN COMMUNITY CONCOURSE  
PROPERTIES:

To achieve savings in overall financing  
costs and to increase funds available for capital  
projects, shall the City incur a bonded indebted-  
ness in the principal amount of Eleven Million  
Five Hundred Thousand Dollars to accomplish the  
immediate purchase from bond funds of certain  
Community Concourse properties which constitute  
a City Plan?

This Proposition requires a two-thirds vote.

PROPOSITION G:

PROPOSITION G. CITY OF SAN DIEGO CHARTER AMENDMENT. AMENDS SECTION 129 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Provides authority to protect employees charged with misconduct from immediate or premature discipline by providing for a temporary nondisciplinary suspension pending complete investigation of such charges of misconduct.

PROPOSITION H:

PROPOSITION H. CITY OF SAN DIEGO CHARTER AMENDMENT. AMENDS SECTION 130 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Assigns to the Civil Service Commission the responsibility to prepare and furnish annually to the City Council timely and appropriate salary information for the guidance of the Council. Deletes the duty that the Commission be required to prepare and furnish a schedule of compensation each year.

PROPOSITION J:

PROPOSITION J. CITY OF SAN DIEGO CHARTER AMENDMENT. ADDS SECTION 129.1 TO THE CHARTER OF THE CITY OF SAN DIEGO.

Prohibits strikes by City employees. Authorizes dismissal of striking employees in accordance with applicable provisions of the Charter. Provides that employees be assured and accorded due process of law. Provides further that no official of the City shall have authority to grant amnesty to any City employee who has violated the "No Strike" provision of this Charter and excludes appeals to the Civil Service Commission from disciplinary action authorized by this section. Prohibits Council from granting any increases over those in effect or last offered by the City prior to any strike or concerted action and further prohibits any increases beyond that in effect or last offered until the following year meet and confer negotiations.

WHEREAS, a copy of the certificate of the Registrar of Voters of the County of San Diego canvassing the returns of the special municipal bond election and the special municipal election, including absentee votes cast, as certified to the Clerk of the Board of Supervisors, has been duly received; and

WHEREAS, a canvass of the special municipal bond election and the special municipal election has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code as follows:

1. The total number of votes cast in the City, including absentee votes, is 246,717.

2. The number of votes, including absentee votes, cast for and against each of the four propositions lettered F, G, H, and J and the total number of votes cast upon each proposition, including absentee votes, are as follows:



3. Propositions G and J received the affirmative vote of a majority of the qualified voters voting on said propositions and are hereby declared to have been approved. Proposition F did not receive the affirmative vote of a two-thirds' majority of the qualified voters voting on said proposition and is hereby declared to have failed. Proposition H did not receive the affirmative vote of a majority of the qualified voters voting on said proposition and is hereby declared to have failed.

4. The number of votes cast, including absentee votes, is recorded in the Election Returns Book, which book is a part of the records of this Council.

5. The City Clerk shall make public the results of the canvass of the special municipal bond election and the special municipal election by publication of a copy of this resolution.
