VACATION OF A PORTION OF ALLEY IN BLOCK 181, MISSION
BEACH MAPS NO. 1651 AND NO. 1809.

WHEREAS, it is proposed that a portion of ALLEY in Block 181,
Mission Beach Maps No. 1651 and No. 1809 be vacated; and

WHEREAS, there is no present or prospective use for the alley
either for the public street system for which the right-of-way was
originally acquired or for any other public use of a like nature
that can be anticipated; and

WHEREAS, the public will benefit from the vacation through
improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with
the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way
was originally acquired will not be detrimentally affected by this
vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
California, that a portion of ALLEY in Block 181, Mission Beach
Maps No. 1651 and No. 1809, as more particularly referred to in
Resolution of Intention No. 216133 is unnecessary for
present or prospective public street purposes.

BE IT FURTHER RESOLVED, that a portion of ALLEY in Block 181,
Mission Beach Maps No. 1651 and No. 1809, as more particularly
shown on Map No. 13707-B, on file in the office of the City Clerk

as Document No. 755510, which said map is attached hereto
and made a part hereof, be and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a
certified copy of this resolution, attested by him under seal, to
be recorded in the office of the County Recorder.

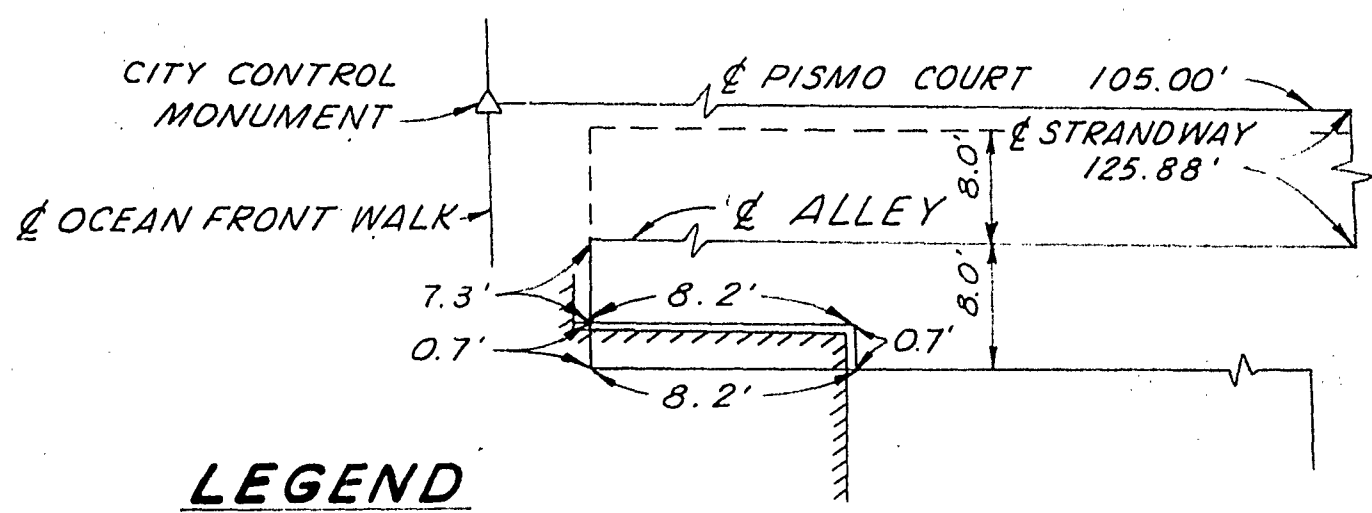
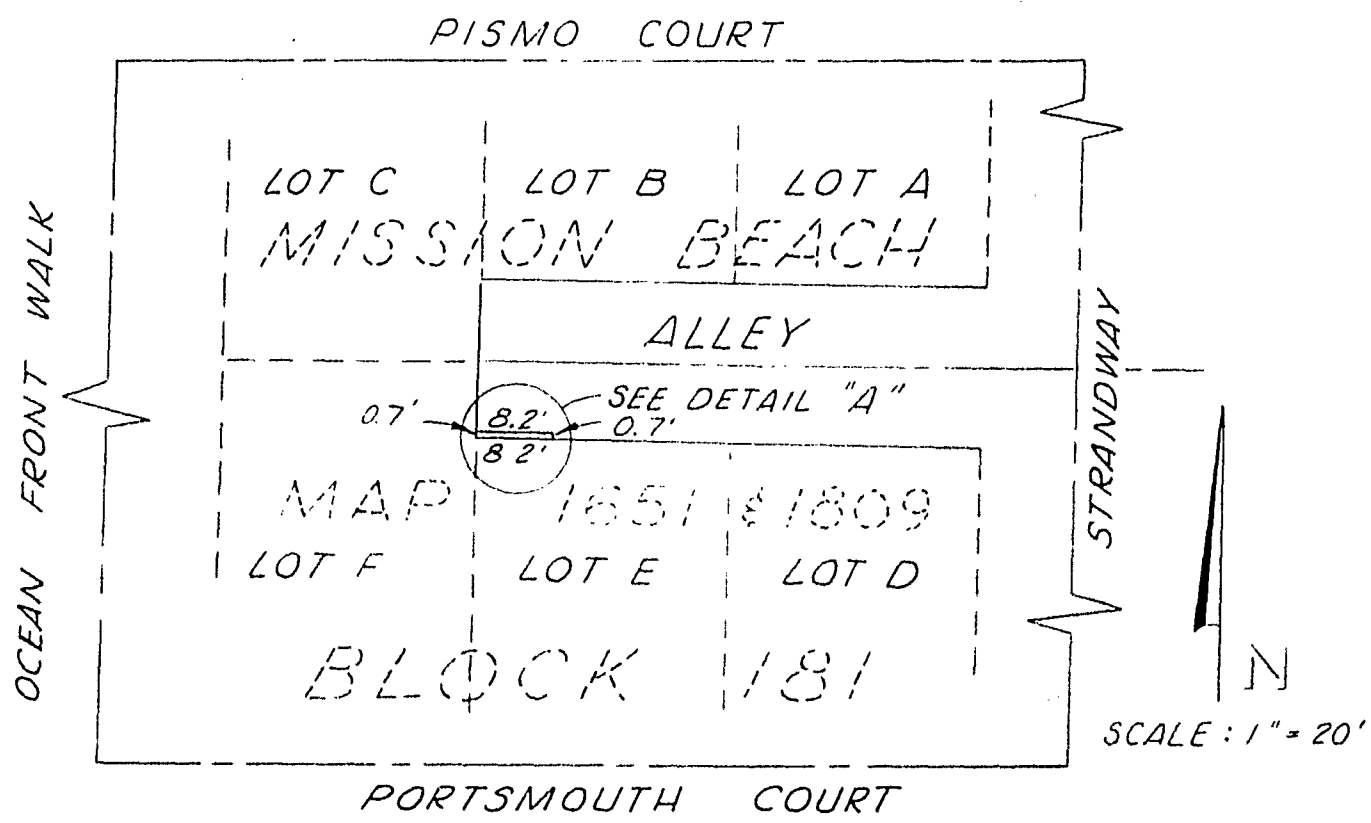
