WHEREAS, that portion of ROAD SURVEY 294 has been relocated through an alternate route dedicated and approved on May 26, 1961 by Resolution No. 166080; and



1. That ROAD SURVEY 294, adjacent to Beyer Way, as more particularly shown on Drawing No. 13674-B, on file in the office of the City Clerk as Document No. 756065, which said drawing is attached hereto and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
