WHEREAS, The City of San Diego is the owner of a portion of Lots 19, 67, 68, and 70, Rancho Mission, and portions of La Mesa Colony; and

WHEREAS, the SAN DIEGO COUNTY WATER AUTHORITY, a public corporation, has requested that the City convey to it an easement for water pipeline purposes in and to said property to provide a paralleling 69" pipeline to the Alvarado Filtration Plant; and

WHEREAS, the Water Utilities Director has no objection to the conveyance of said easement; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego County Water Authority, a public corporation, in the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed of easement, the form of which is on file in the office of the City Clerk as Document No. 756035 conveying to the San Diego County Water Authority, a public corporation, an easement for water pipeline purposes affecting a portion of Lots 19, 67, 68, and 70, Rancho Mission and portions of La Mesa Colony, as more particularly described in said form of deed of easement.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
