ROBERTS, executed in favor of The City of San Diego, bearing date of March 3, 1976, conveying to said City the permanent easement and right of way for a public street or streets, and incidents thereto, through, over, under, upon, along and across a portion of Section 34, Township 18 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named TOCAYO AVENUE.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
