


RESOLUTION No. 216446Adopted on JUL 21 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LEONARD and JOANETTA PRITCHARD, husband and wife, executed in favor of The City of San Diego, bearing date of December 23, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot 19, Cave and Mc Hatton's Subdivision of Lot 14, and a portion of Lot 16, Rancho Ex-Mission, according to Map thereof No. 159, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 61ST STREET.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
