WHEREAS, the Property Department has requested that the City revest these abutter's rights of access in the property to THE CITY OF SAN DIEGO, to clear a cloud on the title of said property; and


WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 756055, to THE CITY OF SAN DIEGO, effecting the revestment of those abutter's rights of access in and to Genesee Avenue, Miramar Street, East Gate Mall and Regents Road, affecting Lot 2 of Collegiate Park Subdivision, heretofore relinquished to the City, more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be,
and he is hereby authorized and directed to deliver said deed to
the Property Director of said City for further handling.
