BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$98,587.00 from Sewer Unallocated Reserve 506-69.97-3485 to 506-69.42-3293 for the sole purpose of providing funds for the above stated purpose.
