

RESOLUTION No. 216462Adopted on JUL 21 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:


1. That the City Manager is hereby authorized and directed to execute, for and on behalf of The City of San Diego, an agreement with PENASQUITOS, INC., an Illinois corporation, providing for the acquisition of Lot No. 339 Penasquitos Glens Unit No. 6, for park purposes, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 756063.

2. That the expenditure from Park Fee Fund No. 11145 of \$24,900, the release of park fee bonds (District No. 11145) in the amount of \$24,500, the granting of subdivision park fee credit against Penasquitos Glens Unit No. 7 in an amount not to exceed \$27,000, for a total not to exceed \$76,400, be and the same is hereby approved.

3. That the expenditure of not to exceed \$41,600 from Capital Outlay Fund 245 (CIP 20-008 Cooperative Park Projects) to match the equivalent contribution of PENASQUITOS, INC., of park land in an equal value, is hereby authorized and approved.

4. That this Council does hereby commend PENASQUITOS, INC., for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to PENASQUITOS, INC.
