WHEREAS, ONELIA M. RIVERA, dba Multilingual Guide Service, has applied to the City Council for two Certificates of Public Convenience and Necessity to operate automobiles for hire and two Certificates of Public Convenience and Necessity to operate sight-seeing vehicles within the limits of the City of San Diego; and

WHEREAS, pursuant to Sections 72.0204 and 72.0304 of the Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(a) There appears to be an increasing demand for multilingual tour services. Since starting operations in June of 1975, the applicant has been unable to supply all requests for service. Issuance of the additional certificates will enable Multilingual to more adequately service their clientele.

(b) There are six other auto-for-hire and sightseeing firms certificated to operate in the City of San Diego.

(c) The Company appears to be financially sound.

(d) The vehicles to be used are: 1975 15-passenger Dodge vans. The vans will have a white and blue color scheme.

(e) This service will not significantly add to traffic congestion or parking problems in the City.

(f) This service will not increase hazards to the public.

(g) Company references have been satisfactorily checked.


WHEREAS, the Council this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Onelia M. Rivera, dba Multilingual Guide Service, having filed an application for two Certificates of Public Convenience and Necessity to operate automobiles for hire and two Certificates of Public Convenience and Necessity to operate sight-seeing vehicles pursuant to the provisions of Sections 72.0202 and 72.0302, respectively, of the San Diego Municipal Code, and the City Manager having conducted the required investigation, four Certificates of Public Convenience and Necessity are hereby granted to Onelia M. Rivera to operate the vehicles specified in the application subject to compliance with all provisions of the San Diego Municipal Code.
