

RESOLUTION NO. 216465

WHEREAS, WILLIAM J. JENKINS, dba Bill's Cab Company, has applied to the City Council for two Limited Certificates of Public Convenience and Necessity to operate taxicabs within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.0101(d) of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has filed his written report with this Council, which report indicates:


- (a) There is an apparent demand for this service.
- (b) The Del Mar Heights area is serviced by San Diego Transit Corporation and Yellow Cab Company. The transit schedule is limited in times and runs. Recent taxi surveys indicate that moderate to long waiting times can be expected.
- (c) The applicant presently operates a taxi company in the Del Mar area. His operation appears financially sound.
- (d) There are two vehicles to be used: a 1972 Plymouth 4-door sedan; a 1973 Dodge 4-door sedan. Both vehicles have a 5-passenger capacity and are blue and white in color.
- (e) The taxi operations would not significantly add to traffic congestion or parking problems.
- (f) The taxi operations would not increase hazards to the public.
- (g) The applicant's references have been satisfactorily checked.

WHEREAS, the Council this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

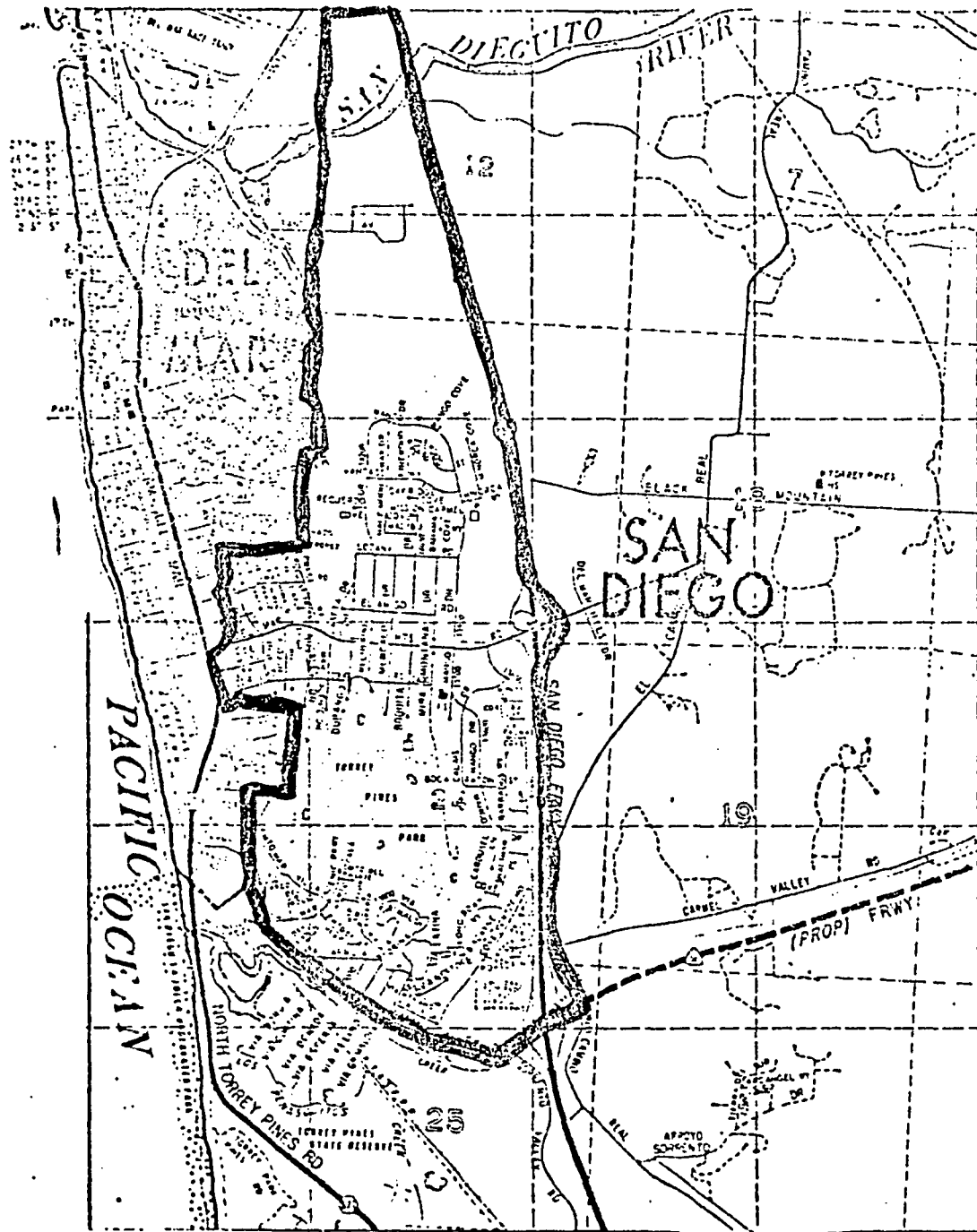
That William J. Jenkins, dba Bill's Cab Company, having filed an application for two Limited Certificates of Public Convenience and Necessity to operate taxicabs pursuant to the provisions of Sections 72.0101(b) and 72.0101(m) of the San Diego Municipal Code, and the City Manager having conducted the required investigation, the City Council hereby grants two Limited Certificates of Public Convenience and Necessity, limited to the pick-up areas of the Del Mar Heights area as indicated on the attached map, to William J. Jenkins to operate the vehicles specified in the application subject to compliance with all provisions of the San Diego Municipal Code.
