Jules A. Glassman	Building Inspection	\$ 210	Mr. Glassman is an Investigator in the Building Inspection Department. He suggested that an application form be sent to complainants to reduce the time spent by staff on the telephone. Not only has time on the phone been reduced, but citizens requesting service appreciate being able to initiate the case at their leisure. It is estimated that this suggestion saves \$2,112 per year.
Earl G. Schweizer	Fire	\$ 210	Mr. Schweizer is a Storekeeper I in the Fire Department. He discovered a method of repairing oxygen deficiency and combustible gas indicators so that only the combustible gas indicator was operable. The multipurpose indicator had been withdrawn from service due to excessive expense in repairing. Mr. Schweizer's suggestion resulted in cancellation of a purchase order for gas indicators and saved the City \$2,117.
