BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$220 from the General Purpose Revolving Fund (534) for the purpose of defraying expenses incurred in the above travel.

BE IT FURTHER RESOLVED, that the total cost of said travel, including 40% of officer's salary, shall be reimbursed to the City of San Diego by the Peace Officers Standards and Training (P.O.S.T.).
