RESOLUTION NO. 216498

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be authorized to execute the following twenty-three (23) agreements with community agencies for the purpose of carrying out various social programs during the eleven-month period extending from August 1, 1976 through June 30, 1977, and to expend up to \$860,741 in Revenue Sharing funds for said purposes.

The social programs, agencies, and contract document numbers shall be as contained in the forms of agreements on file in the office of the City Clerk as follows:
