WHEREAS, said allocation and augmentation have been expended in support of PUC litigation and hearings and it is now desired and necessary to augment again said resolution to continue participation by San Diego in this field of concern; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of five thousand dollars (\$5,000)

within Fund 100 from the Unallocated Reserve (53.30) to the Allocated Reserve (53.20) for the sole and exclusive purpose of providing funds to augment Resolution No. 208152 for expenses incurred in connection with said participation in the above hearings.
