WHEREAS, the City Council, by Resolution No. 207396 dated February 20, 1973, authorized the City Attorney or his designated representative to incur all necessary expenses in connection with participation on behalf of The City of San Diego in those certain hearings to be held before the California Public Utilities Commission in the matter of rate increase applications by the Pacific Telephone and Telegraph Company in Application No. 53587; and

WHEREAS, the Council authorized funds be set aside from the Unallocated Reserve for the above purpose in order to defray continuing costs incurred in such participation; and

WHEREAS, the Council by Resolution No. 213956 dated August 6, 1975, augmented said Resolution No. 207396 to provide funds for continued participation in those rate hearings; and

WHEREAS, the Pacific Telephone and Telegraph Company has continued its efforts in rate increase applications and presently is continuing with protracted hearings in Applications Nos. 55492 and 51774, et al; and


WHEREAS, said original allocation and augmentation of funds have been expended in support of participation in said hearings and it is now desired and necessary to augment again said resolution to continue participation by San Diego in this field of concern; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of five thousand dollars (\$5,000) within Fund 100 from the Unallocated Reserve (53.30) to the Allocated Reserve (53.20) for the sole and exclusive purpose of providing funds to augment Resolution No. 207396 for expenses incurred in connection with said participation in the above hearings.
