RESOLUTION CONSIDERING THE PROTESTS, APPROVING THE AMENDED ENGINEER'S REPORT, CONFIRMING THE ASSESSMENT FOR THE SAN DIEGO STREET LIGHTING MAINTENANCE DISTRICT NO. 1 FOR THE PERIOD OF JULY 1, 1976 THROUGH JUNE 30, 1977, DISSOLVING TWO AREAS FROM SAID DISTRICT, AND AMENDING MAPS OF SAID DISTRICT.

(SAN DIEGO STREET LIGHTING MAINTENANCE DISTRICT NO. 1)

WHEREAS, Resolution of Intention No. 216376, adopted JUL 7 1976, declared this Council's intention to order the confirmation of assessments for the San Diego Street Lighting Maintenance District No. 1 for the period July 1, 1976 through June 30, 1977; and

WHEREAS, on the date, time and place set forth in said resolution, a public hearing was held with opportunity being given to those persons desiring to protest; and

WHEREAS, pursuant to Chapter 6, Article V, Division 2, Sections 65.0201 through 65.0222 of the San Diego Municipal Code, the Council has considered and reviewed the costs to be assessed for the supplying of energy, maintenance and service for the ensuing year; and


WHEREAS, the Engineer's Report relative to the estimated energy and maintenance costs for Fiscal Year 1977 which was approved by Resolution No. 216375 has been amended and a copy of the amended Engineer's Report has been prepared, submitted and filed in the Office of the City Clerk as Document No. 756082; and

WHEREAS, the proposed assessments for the said maintenance district are on file in the office of the Street Superintendent and have been made available for public inspection; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The amended Engineer's Report submitted in connection with the said district and filed in the Office of the City Clerk as Document No. 756082, is hereby approved.
3. The assessments described in said Resolution of Intention No. 216376 and on file in the office of the Street Superintendent of The City of San Diego Street Lighting Maintenance District No. 1 for the period July 1, 1976 through June 30, 1977, are hereby confirmed and approved as the amounts to be assessed to the individual properties within the lighting district.
4. Area 6, Mission Beach No. 2, and Area 51, Mission Beach No. 1 are hereby dissolved from said district.
5. The amended maps of said district be approved to show the consolidation, lot splits and the dissolution of Area 6 and 51 as shown on the amended maps of said district on file in the Office of the City Clerk as Document No. 756083.
