WHEREAS, the Council of The City of San Diego, at its meeting of November 14, 1974, adopted Resolution No. 211997 confirming and approving the Street Superintendent's Assessment covering the cost and expenses of certain public improvements made under the provisions of the Improvement Act of 1911; and

WHEREAS, Section 5450 of the Streets and Highways Code provides that the legislative body may, upon written request of the contractor or his assigns, direct that assessments of less than fifty dollars (\$50) levied under the provisions of the Improvement Act of 1911 be collected upon the tax roll; and

WHEREAS, the assignee of the contractor of the above-mentioned project has requested, pursuant to the provisions of Section 5450 of the Streets and Highways Code, that certain assessments of an amount less than fifty dollars (\$50) be collected through the County tax roll; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the County of San Diego is authorized and directed to collect the assessments described in a document on file in the office of the City Clerk as Document No. 756212, pursuant to Sections 5450 through 5455 of the Streets and Highways Code.
