
Adopted on AUG 4 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to submit, for and on behalf of said City, to the U. S. Department of Labor (Employment and Training Administration) a proposed First Amendment to Agreement and to execute said agreement which would extend the current assignment of Erika E. Streuer to serve for a second year as Special Assistant to the Director of the Human Resources Department for the time period extending from November 10, 1976 through November 9, 1977, pursuant to the terms and conditions set forth in the transmittal letter and form of First Amendment to Agreement on file in the office of the City Clerk as Document No. 756232.

BE IT FURTHER RESOLVED, that an amount not to exceed \$15,300 in CETA Administration funds be used to reimburse the Department of Labor for wages and fringe benefits on a quarterly basis for the services of Ms. Streuer.
