That the bid of Consolidated Facility Services, Inc. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SECURITY SERVICE for a period of one (1) year beginning July 1, 1976, through June 30, 1977, at a cost of \$4.36 per hour; terms net 30 days; with an option to renew for four (4) additional one (1) year periods at the bid price subject to an escalation not to exceed 8% of bid price, per year.
