
Adopted on AUG 4 1976

That the City Manager or his designated representative is hereby authorized to execute, for and on behalf of The City of San Diego, the First Amendment to the Agreement between The City of San Diego and NASLAND ENGINEERING, INC., providing for additional engineering services in connection with the design and construction of improvements for Torrey Pines Science Park Unit No. 2, under the terms and conditions set forth in the copy of First Amendment to the Agreement on file in the office of the City Clerk as Document No. 756236.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is authorized to expend the additional sum of \$⁴⁰⁰61,900 from Land Development Trust Fund (314) for the above stated services and related costs, supplementing Resolution No. 211023 in said amount for a total authorization of not to exceed \$78,000.
