

RESOLUTION NO. 216543 **AUG 4 1976**

WHEREAS, Nancy Bradshaw, a candidate for Board of Education, District A, has submitted an APPLICATION FOR DEFERMENT OR WAIVER OF THE \$249.69 QUALIFICATION STATEMENT FEE for the purpose of deferring her pro rata share of costs incurred by the City Clerk in producing said Statement of Qualification during the Municipal Primary Election held September 16, 1975; and

WHEREAS, in said application Candidate Bradshaw has declared, under penalty of perjury, that she is indigent; and

WHEREAS, because of her claimed indigency Candidate Bradshaw is requesting that the aforementioned Statement of Qualification cost of \$249.69 be deferred, to be paid to the City of San Diego out of contributions, if any, received by said candidate or by any committee supporting her, in excess of \$3,000; and

WHEREAS, this Council has, without independent investigation, considered Candidate Bradshaw's application for deferment, including the personal financial data thereon, in light of the standards required for indigency in civil matters as determined by the courts of the State of California; NOW, THEREFORE;


BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the Council of The City of San Diego, based upon the APPLICATION FOR DEFERMENT OR WAIVER OF THE QUALIFICATION FEE executed by Candidate Bradshaw on March 29, 1976, and on file in the office of the City Clerk as Document No. 756370, hereby finds that Candidate Bradshaw is indigent for the purposes of payment of her pro rata share of the Statement of Qualification expenses.

2. That by reason of said indigency, this Council does hereby defer the \$249.69 Statement of Qualification cost incurred by Candidate Bradshaw, such cost to be paid by Candidate Bradshaw at such time any contributions are received by said candidate or by any committee supporting her.
