That the bid of Pfizer Inc., MPM Div. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of BULK QUICKLIME, as may be required for a period of one (1) year beginning August 1, 1976, through July 31, 1977, at a cost of \$33.00 per ton; terms net 30 days, plus a freight charge of \$13.60 per ton; and an escalation clause granting price increases not to exceed 10% of bid price.
