BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of a Director's Deed executed by the State of California, acting by and through its Director of Transportation, executed in favor of The City of San Diego, bearing date of February 24, 1976, conveying to said City an easement for sewer line purposes and appurtenances thereto, over, under and across portions of Lots 8, 9, 15, 16, 18, 23, 24, 27, 46, 47, 48, 49 and 50 of Lemon Garden Acres, according to Map No. 1390; a portion of Lot 44 of a portion of the Ex-Mission Lands of San Diego, according to Map No. 283; portions of Lots 31, 32, 36, 37, 43, 50, 51 and 53 of Lise' Terrace, according to Map No. 3616; portions of Lots 90, 92, 93, 94, 100, 101, 102 and 115 of Chollas View Subdivision Unit No. 1, according to Map No. 3864; as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
