APPROVING MAP OF VAN CASTER SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "VAN CASTER SUBDIVISION Being a subdivision of a Portion of Lot 65 of Rancho Mission of San Diego (including a Portion of Mission Gorge Road as vacated and closed to public use), in the City of San Diego, County of San Diego, State of California, according to partition Map thereof made in the action entitled 'Juan M. Luco, et al, vs. The Commercial Bank of San Diego, et al,' under Superior Court Case No. 348, on file in the office of the County Clerk of San Diego County, together with a portion of Mission Gorge Road as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Zion Avenue, for public purposes; and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and

egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated; and that that certain easement for drainage facilities as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
