BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Council Resolution No. 212135 is hereby amended to add the following provision:

BE IT FURTHER RESOLVED, that the funds hereby transferred shall be an advance to Redevelopment Fund 985 and shall be repaid from project tax increments or other sources, as appropriate.
