BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized to include in the August Appropriation Ordinance two additional Revenue Sharing Program Monitor positions in the Human Resources Department, said positions are to be filled for a period of ten months at a total cost of \$30,629.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to allocate \$30,629 in Entitlement Period VI Revenue Sharing funds to reimburse the General Fund for the above stated expenditure, contingent upon amendment to the Revenue Sharing Fund Appropriation Ordinance.
