

RESOLUTION NO. 216599

WHEREAS, MEXCURSIONS, INC., dba San Diego/Tijuana Tours, has applied to the City Council for seven (7) Certificates of Public Convenience and Necessity to operate automobiles for hire and seventeen (17) Certificates of Public Convenience and Necessity to operate sight-seeing vehicles within the limits of the City of San Diego; and

WHEREAS, pursuant to Sections 72.0204 and 72.0304 of the Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(a) There seems to be an increasing public demand for this type of service.

(b) There are five other auto-for-hire and sight-seeing firms certificated to operate in the City of San Diego. One of these firms, Cush Tours, offers a similar service.

(c) The company appears to be financially sound.

(d) The vehicles to be used are: 14-passenger Dodge vans, 16-passenger Mercedes Benz buses, a 45-passenger Flexible, and a 46-passenger Silver Eagle.

(e) This service will not significantly add to traffic congestion or parking problems in the City.

(f) This service will not increase the hazards to the public.

(g) Company references check satisfactorily.


WHEREAS, the Council this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Mexcursions, Inc., dba San Diego/Tijuana Tours, having filed an application for seven (7) Certificates of Public Convenience and Necessity to operate automobiles for hire and seventeen (17) Certificates of Public Convenience and Necessity to operate sight-seeing vehicles pursuant to the provisions of Sections 72.0202 and 72.0302, respectively of the San Diego Municipal Code, and the City Manager having conducted the required investigation, twenty-four (24) Certificates of Public Convenience and Necessity are hereby granted to Mexcursions, Inc. to operate the vehicles specified in the application subject to compliance with all provisions of the San Diego Municipal Code.
