WHEREAS, GEORGE MUHLBACH, dba George's Sightseeing Tours, has applied to the City Council for a Certificate of Public Convenience and Necessity to operate a sightseeing vehicle within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.0304 of the Municipal Code, the City Manager has conducted an investigation to be made and has reported his findings in writing to this Council, which report indicates:-

(a) There seems to be an increasing public demand for this type of service.

(b) There are five other sightseeing firms certificated to operate in the City of San Diego. One of these firms, Multilingual Guide Service, offers a similar service. Multilingual operates four vehicles in providing their service.

(c) The vehicle to be used is a 4-passenger Plymouth Valiant.

(d) This service will not significantly add to traffic congestion or parking problems in the City.

(e) This service will not increase the hazards to the public.


(f) Personal references check satisfactorily.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That George Muhlbach, dba George's Sightseeing Tours,  
having filed an application for a Certificate of Public  
Convenience and Necessity to operate a sight-seeing vehicle  
pursuant to the provisions of Section 72.0302 of the San Diego  
Municipal Code, and the City Manager having conducted the  
required investigation, a Certificate of Public Convenience  
and Necessity is hereby granted to George Muhlbach to operate  
the vehicle specified in the application subject to compliance  
with all provisions of the San Diego Municipal Code.
