WHEREAS, a certain sewer easement was dedicated in Lot 3, Inland Center, according to Map thereof No. 5945 filed in the office of the San Diego County Recorder; and

WHEREAS, the Engineering and Development Department of said City has requested that the City vacate its interest in said easement to clear title to the land; and

WHEREAS, said sewer easement has never been used for the purpose for which it was dedicated since the date of filing of said subdivision map to the present time and more than one (1) year has elapsed; and

WHEREAS, a fee of one hundred thirty dollars (\$130) has been received to cover the processing of this request; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, said easement as hereinafter described is unnecessary for present or prospective public use by the City, and the City Manager recommends that the City vacate said sewer easement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the sewer easement more particularly described as follows is hereby vacated:

All that certain 10.00 foot sewer easement granted to the City of San Diego, all lying within Lot 3 of Inland Center according to Map thereof No. 5945 filed in the Office of the County Recorder of San Diego County on August 25, 1967.

That from and after the date of this order of vacation, title to the land previously subject to said easement shall revert to the owner of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the Recorder of said County of San Diego.
