
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date of June 23, 1976, conveying to said City nine (9) parcels of land for park purposes, described below, and more particularly described in said deed, be and the same is hereby approved:

1. Portion of Lot 820 of East Clairemont Unit No. 6, Andersen Elementary School
2. Lot 396 of San Carlos Estates Unit No. 10, Brewer Elementary School
3. Portion of Lot 3385, Clairemont Unit No.16, Cadman Elementary School
4. Portion of Lot 22 of La Mesa Colony, portion of Clay Elementary School Site
5. Portion of Lot "J" and portion of Lot "I" in Lot 70 of Rancho Mission, Columbus Elementary School
6. Portion of Lot 2 and all of Lot 3 in Block 10 of Encanto Heights, portion of Encanto Elementary School Site
7. Portion of Lot 578, San Carlos Unit No. 7, Portion of Forward Elementary School Site
8. Lot 222 of Park West Unit No. 5, Gershwin Elementary School Site
9. Portions of Cable Road Addition, and a portion of Lot 1 in Pueblo Lot 1186, Rose Elementary School.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
