A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM BY AMENDING DOCUMENT NO. 754397, AS AMENDED, TO ACCELERATE FROM FISCAL YEAR 1981 TO FISCAL YEAR 1977 AND PROVIDE FUNDS FOR C.I.P. PROJECT NO. 23-635, SOUTHEAST SAN DIEGO SPORTS FIELD.

WHEREAS, The City of San Diego has an opportunity to apply for a federal grant that would provide a fifty (50) percent reimbursement for the Phase III development of Southeast San Diego Sports Field; and

WHEREAS, the proposed development is currently scheduled for fiscal year 1981 and an assured source of funding is required in order for the grant to be considered; and

WHEREAS, a grant would permit the acceleration of the project to fiscal year 1978; and

WHEREAS, funds are available from C.I.P. Project No. 29-160.1, Rolando Clay Neighborhood Park South in the amount of \$186,000, said funds no longer being required since the land was acquired through a land exchange with the San Diego Unified School District; and

WHEREAS, additional funds in the sum of \$44,000 are available in the Capital Outlay Fund 245--Unallocated Reserve; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That pursuant to Section 2, subsection 23 of the annual appropriation ordinance, the Capital Improvements Program

as contained in document No. 754397, as amended, be and the same is hereby further amended by accelerating C.I.P. Project No. 23-635, Southeast San Diego Sports Field from the fiscal year 1981 program and adding said Project No. 23-635 to the fiscal year 1977 C.I.P. Program.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer within the 245 Fund the sum of \$186,000 from C.I.P. Project No. 29-160.1(6) and \$44,000 from C.I.P. No. 90-245, Capital Outlay Fund Reserve to provide funds for the above C.I.P. Project No. 23-635.
