Michael Main	GENERAL SERVICES	\$15	Mr. Main was a Crewman II in the Solid Waste Division at the time of this suggestion. He suggested that a piece of rubber be attached to the bottom of the ram blade of Garwood packers. Although no savings could be estimated, this is felt to be a valuable safety suggestion.
Willie Gipson	GENERAL SERVICES	\$15	Mr. Gipson is a supervisor in the Solid Waste Division. He suggested that all refuse packers be equipped with fire extinguishers, flares, and first aid kits. Although no savings could be estimated, this is felt to be a valuable safety suggestion.
Clair Munson	FIRE	\$15	Mr. Munson is a Captain. He suggested that all pump companies responding to emergency situations be notified by radio when the situation is under control. Once this is done, the pump company will continue to the scene of the incident in the regular flow of traffic. Although no savings could be estimated, this is felt to be a valuable safety suggestion.
Elston Eisner	PARK & RECREATION	\$10	Mr. Eisner is a Recreation Facility Caretaker. He suggested that recreation centers use only a portion of their overhead lighting for activities requiring less than the full lighting capacity. Although savings were difficult to calculate, significant savings are expected.
