1. That the bid of \$19,311 by Wilcox Electric Inc., dba Arrow Electric, a corporation for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT 32ND STREET AND UNIVERSITY AVENUE in the City of San Diego, California is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755800.
2. That the expenditure of \$34,284.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT 32ND STREET AND UNIVERSITY AVENUE in the City of San Diego and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$9,716 from CIP No. 62-112 to the Capital Outlay Reserve, CIP No. 90-245.
