

RESOLUTION NO. 216687 SEP 1 1976 R.76-2586

APPROVING MAP OF VILLA MAJORCA UNIT NO. 1 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by JOHN M. LEACH, a Registered Civil Engineer, entitled "VILLA MAJORCA UNIT NO. 1 Being a subdivision of a portion of Lots 27, 29 and 36 of Rosedale Tract, in the City of San Diego, County of San Diego, State of California, according to Map 825 filed in the office of the County Recorder of San Diego County, January 21, 1897, and that portion of vacated street as vacated by Civil Suit 105, U. S. District Court, Book 1181, Page 80, Official Records, dated May 9, 1941.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Paguera Court, a portion of Tierrasanta Boulevard, a portion of Baroque Lane and portions of Ducos Place, for public purposes, and said street and portions of streets are hereby declared to be a public street and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Ducos Place, adjacent and contiguous to Lots 1 through 5, and any and all abutters' rights of access in and to Tierrasanta Boulevard,


adjacent and contiguous to Lots 5 through 10, all as shown on this map within this subdivision.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
