

RESOLUTION NO. 216693 SEP 1 1976

APPROVING MAP OF DALEY BUSINESS PARK UNIT NO. 2

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by FRANK M. POWELL, Registered Civil Engineer, entitled "DALEY BUSINESS PARK UNIT NO. 2 Being a subdivision of all of Lot 6 and portions of Lots 4, 5, and 7 in Block 20, and portions of Lots 6, 7, and 8 in Block 28 of Rosedale, according to Map thereof No. 826, filed in the office of the County Recorder of San Diego County, January 21, 1897, and portions of Fourth Street and of Olive Avenue, as vacated and closed to public use on May 26, 1970 by Resolution No. 190888 of the City Council of The City of San Diego, recorded May 29, 1970 as File No. 93879, and Olive Avenue between said portions of Blocks 20 and 28, as vacated and closed to public use, all being in The City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Ridgehaven Court and Viewridge Avenue, for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the


easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain easements for sewer and drainage facilities as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, all as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
