

RESOLUTION NO. 216696 SEP 1 1976

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of OLIVE AVENUE has been relocated by the approval on this date of the dedication of Ridgehaven Court and Viewridge Avenue by the acceptance of the final map of the subdivision to be known as DALEY BUSINESS PARK UNIT NO. 2; and


WHEREAS, those properties adjoining that portion of OLIVE AVENUE to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as Daley Business Park Unit No. 2; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That OLIVE AVENUE, as more particularly shown on Drawing No. 13682-B, on file in the office of the City Clerk as Document No. 756559, which said drawing is attached hereto and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder of San Diego County.

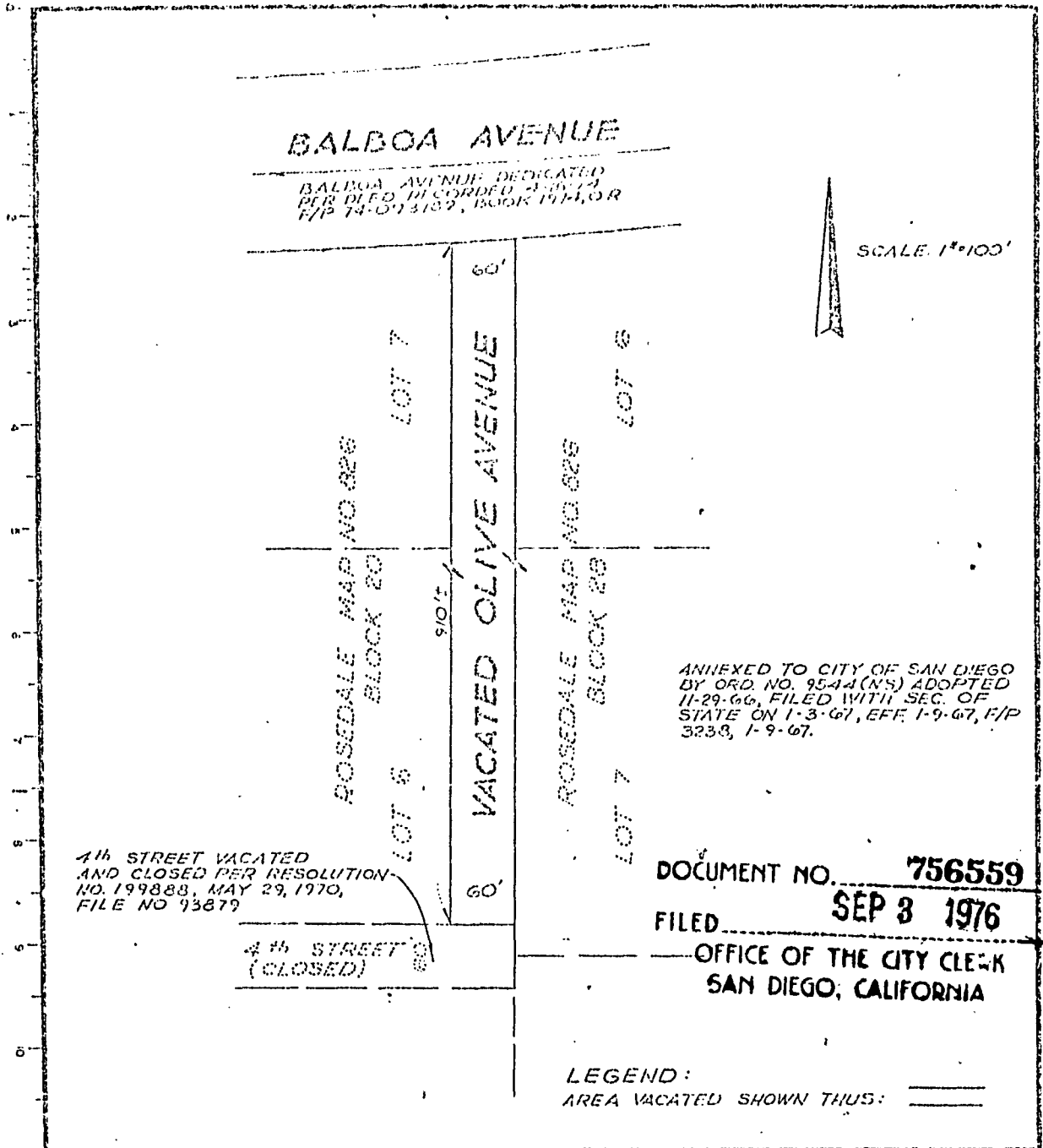
