BE IT FURTHER RESOLVED, that the expenditure of \$8,470 and \$4,000 is hereby authorized out of Gas Tax Fund 220 and Capital Outlay Fund 245, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced services.
