WHEREAS, the Cabrillo Festival is incorporated as a nonprofit corporation to plan and coordinate the annual Cabrillo Festival which endeavors to authentically recreate the arrival of Cabrillo on the shores of San Diego; and

WHEREAS, the festival program is designed to promote and advertise the marine facilities of the City; and

WHEREAS, the festival program is further associated with publicizing the role of the Portuguese people in the settlement and early years of San Diego; and

WHEREAS, the Portuguese Heritage Foundation, in cooperation with the Government of Portugal, has developed an exhibit entitled "Portuguese in America" to be offered as a further effort to promote the cultural heritage of the early San Diego settlers of Portuguese extraction; and

WHEREAS, said exhibit is to be displayed to the general public free of charge at the Conference Building in Balboa Park from September 26 through October 3, 1976; and

WHEREAS, the use of said building normally requires payment of \$400 per day as rental; and

WHEREAS, Cabrillo Festival, Inc. (herein called "Festival") has requested that the City cosponsor with Festival said exhibit and waive thereby the rental fee for the period of the exhibit;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an appropriate agreement with Cabrillo Festival, Inc. to cosponsor the exhibit entitled "Portuguese in America" to be displayed at the Conference Building in Balboa Park during the period September 26 through October 3, 1976.

BE IT FURTHER RESOLVED, that the rental fees for use of the Conference Building during the above period be and the same are hereby waived.
