

WHEREAS, by Document dated January 23, 1975, the City entered into an agreement with Lucy L. Killea under the terms of which she provided full-time consultant services for Fronteras 1976 and was compensated at the rate of \$1,250 per month; and

WHEREAS, it is no longer necessary that Mrs. Killea provide full-time services and it is recommended that the agreement be amended to provide compensation at the rate of \$625 per month commencing September 1, 1976 and ending December 31, 1976, for which compensation Mrs. Killea will provide consultant services as necessary for Fronteras 1976; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a First Amendment to Agreement with Mrs. Lucy Killea providing for consultant services for Fronteras 1976 from September 1, 1976 to December 31, 1976 at a rate of \$625 per month, under the terms and conditions set forth in the form of first amendment to agreement on file in the office of the City Clerk as Document No. 756609.
