

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with BERRYMAN, MOHLE, STEPHENSON & PERRY, INC. for professional engineering services for design of traffic signal and safety lighting systems at the intersection of NORTH HARBOR DRIVE and SCOTT STREET, and the intersection of SANTA MONICA AVENUE and SUNSET CLIFFS BOULEVARD, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 756612.

BE IT FURTHER RESOLVED, that the sum of \$4,600 be transferred from Gas Tax Fund 220, sources CIP Projects Nos. 61-123(6), \$2,600, and 61-125(6), \$2,000 to the 244 Fund, Program/Element 4508 to be expended solely and exclusively for the purpose of providing funds for the above-referenced services.
